- Nothing can be staked into the ground, nailed, hung or attached to any structure or tree. All equipment, furniture and signage must be freestanding and able to be carried to site by hand.
- No political filming is allowed.
- Please treat our memorials with dignity and respect.
- A different booking form is required for <u>commercial filming</u> (including wedding photography, promotional activities, commercial filming).
